Dedication of Plaque at Doane Homestead Plot Eastham, Mass., Oct. 1, 1994

At the reunion at Doane College this past summer, a proposal to place a marker on the site of the original Doane Homestead in Eastham, Mass., to commemorate the 350th Anniversary of the town founding was approved. The Doane Family Foundation gave financial support to the project as did many members. The New England Chapter, under President George Doane, was the sponsor. James Doane, their historian, was most active in setting up the historical background.

The dedication ceremony was scheduled for October 1, 1994. The bronze plaque on a granite slab honored all seven of the original founding families: Bangs, Cook, Doane, Higgins, Small (Smalley) and Snow. Representatives of all but the Smalls were present.

The New England Chapter arranged for the use of the National Seashore Visitor's Center auditorium. In his opening remarks, George Doane pointed to Eastham as the "beginning point from which people migrated to build this nation."

Dorothy Doan Baker, International President of the Doane Family Association, recalled previous ceremonies, especially the one in 1869, when on the same plot, the Honorable John Doane had a granite marker erected which still stands.

Selectman Donald Sparrow, whose family tree includes five of the seven original families, traced the history of the part of Nauset incorporated at Eastham.

Joyce Higgins Howard of Indian Mills, N. J., read a poem sent by Louise Nelson, a member of the Higgins family from Washington State. The New England Chapter provided a picnic

lunch near the homestead site and the company moved to unveil the bronze marker. The Rev. George Higgins of Eastham led a prayer asking God's blessing on "the children of time who are gathered to remember those who have preceded us."

The dedication was well attended by folks from the New England States as well as from Delaware, Kentucky, New Jersey, New York, Pennsylvania and Virginia.

Recipe for Mystery Couple

A message from Richard H. and Jean W. Thomas, 920 Fairacres Drive, Kettering, OH 45429:

While attending the Doane reunion this summer, we had lunch with a lovely couple whose father (I can't remember whether his or hers) kept bees. We discussed bees at length. I mentioned that I had a good, easy recipe for baked chicken with honey, and I would send it to her. She gave her name and address to me which I put in my shirt pocket. When we arrived home from Doane College, I washed the shirt with the name and address in it, and neglected to check the pocket. I have a superb washer! It erased every bit of ink from that piece of paper. Whoever you are, I hope you will read this newsletter and remember. This is the only way I can get the recipe to you.

CHICKEN DIABLE

2 large chicken breasts (split in 2 pieces)
4 T (1/2 stick) margarine
1/4 cup honey
1/4 cup prepared mustard
1 tsp. salt
1 tsp. curry powder

Wash chicken breasts, pat dry and remove skin. (Boning them is good too.) Melt margarine in shallow baking pan; stir in remaining ingredients. Roll chicken breasts in margarine mixture to coat both sides, then arrange meaty side up in single layer in same pan. Cover with foil. Bake in 375° oven, 35 minutes with foil on top and 30 minutes uncovered. Baste occasionally during last 30 minutes.

Captain Deborah Doane Dempsey

An article from the Professional Mariner Magazine entitled "Desperate Night on a Dead Ship" was submitted by L. Scott Doane of Trenton, Maine. Scott Doane is a retired Boston Harbor Pilot, being connected to the sea and ships, who had heard about Captain Deborah Doane Dempsey.



Captain Dempsey and her crew were

helicoptered to the 634-foot freighter, Lyra, owned by Lykes Brothers. The Lyra had broken adrift from a tow and was rolling helplessly in heavy seas off the North Carolina coast. The ship was unmanned, without power, and was drifting towards Frying Pan Shoals, by then less than 50 miles away. Captain Dempsey and her crew of four worked perilously through the night, and just before midnight, their mission was accomplished. At this point they were 16 miles from Frying Pan Shoals and anchored in about 100 feet of water.

Captain Deborah Doane Dempsey is found in Volume II, page 429, para. 1384.

The photograph cutline read: Capt. Deborah Doane Dempsey, the first woman to graduate from Maine Maritime Academy (MMA) and the first woman to command a U.S. merchant ship in international trade, received an honorary doctor of science degree from Joseph Sewell (center) president of MMA's Board of Trustees and MMA President Kenneth M. Curtis at Saturday's commencement.

The following is an exerpt from the article: In 1976, Dempsey became the first woman to graduate from MMA. She is also the first woman to serve as master of a U.S. flag merchant ship in international commerce and was a regular captain for the Lykes Bros. Steamship Co.

"You are the proof," Curtis said, "that competence is not a matter of gender."

Norman H. Doane



Norman H. Doane, of Cincinnati, Ohio, became a member of the Doane Family Association in 1951. He attended his first reunion in Massachusetts in 1951, accompanied by his father, Charles Doane of West Baden, Ind., and his wife, Virginia, who had persuaded Norman to attend. Both Norman and Virginia became very active in the Doane Family Association, serving on various committees. In 1957, at Plymouth, Mass., Norman, serving as a vice-president, initiated the Endowment Fund. Later, he arranged for gifts to this fund to be tax deductible as it was determined that the DFA was a non-profit organization.

At the 1959 reunion in Eastham, Mass., Norman presented a paper on "The Dones of Utkinson Hall," which was read by Virginia. He made two trips to England for his research. He also entertained those in attendance with slides from past reunions. At this, his fifth reunion, he was elected treasurer. For several years, Norman was in charge of membership and proceedings. He was partially responsible for securing funds for the second printing of *The Doane Family, Vol. 1*.

In the 1963 Proceedings, there is a memorial to Virginia Doane, Norman's beloved wife, who died during that reunion.

One of Norman's many interests has always been art. At many of our reunions, he has

exhibited his paintings. The last reunion he attended was in Georgetown, Ky., in 1988, where he once again had an art exhibit. Many of us in the Doane Family Association have purchased one of his renderings of the Doane crests based on the coat of arms of Sir John Done of Utkinton Hall in Tarporley, England.

Today, Norman resides in an apartment at the New England Club, 8135 Beechmond Avenue, Cincinnati, Ohio 45255. He continues his art and displays it there. The members of the Doane Family Association today have many reasons to salute this gentleman who is responsible for the current financial stability of our organization. Although he now is unable to attend DFA reunions, he would welcome visits and cards from any of you.

POLICE CHASE DOWN ARMED ROBBERY SUSPECTS

An armed robbery of the Milan Super Valu resulted in a high speed chase with Milan Police and the arrest of two Greensburg men and a 17-year-old Greensburg girl.

According to Tom Holt, Milan Police Department, two masked men entered the store about 10:40 p.m., one armed with a semi-automatic 9 mm handgun, the other with a tire iron.

Store cashier John Muschong wrote in his statement to police, "I was standing at the counter when they walked in and stuck a gun to me and told me to open the drawer."

Muschong said he was nervous and pushed the wrong buttons at first and the drawer did not open.

One of the masked men told Muschong that he had five seconds to open the cash drawer or he was dead. The masked robber started counting down, and Muschong finally got the drawer open.

"The one with the gun moved me to the window and held the gun on me," Muschong told police. The other man, at the cash drawer said, "We've hit the jackpot."

Trying to exit the store, the two robbers ran into the entrance door thinking it was the exit. The door did not open, and the man with the gun turned around and waved it at Muschong. Holt explained that the Super Valu entrance and exit doors are the opposite of most other stores.

Lt. Gustavus C. Doane

My brother, James F. Doan, of Daytona Beach, Fla., and I attended the 43rd International DFA Reunion in Crete, Neb. At the conclusion of the reunion, we spent several weeks touring the West in his motor home. While visiting Yellowstone National Park, I discovered a book in their museum and genealogy department entitled Battle Drums and Geysers, The Life and Journals of Lt. Gustavus Cheney Doane. This book was authored by Orrin and Lorraine Bonney. Mr. Bonney has since passed away, but I have been in touch with Lorraine Bonney in Kelly, Wy. She does not have any hardback books left, but this book is now sold in three volume paperback set. Gustavus C. Doane was such an interesting man, both as an explorer and as a soldier, that I want to share what has been written about him in our Doane Volume II, #663, page 66. Since I am not a longtime member of DFA, I hope I am not repeating what has been published about this great man in previous newsletters.

SOLOMON⁷ DOANE (Joshua⁶, Joshua⁵, Solomon⁴, Samuel³, John², John¹) was b. Sept. 4, 1813, d. of lockjaw, Aug. 5, 1866; m. Nancy Davis, a native of Penna. He lived in Galesburg, Ill., St. Louis, Oregon and arrived in California, May 8, 1849 on the English Bark "Janet." He became a farmer at Alamo, Calif. Children:

i. Gustavus Cheney, ⁸ b. May, 29, 1840, Galesburg, Ill., d. Bozeman, Mont., May 5, 1892; 1m. 1867/68, Amelia Link of Yazoo City, Miss. (div. Sept. 23, 1878, Virginia City, Mont.); 2m. at Helena, Mont., Dec. 16, 1878, Mary Lee Hunter, b. July 7, 1859, Chester, Ill., d. June 25, 1952, Bozeman. No issue.

The career of this remarkable man, a soldier and explorer, began in 1846 when he went with his family by ox team to Oregon. In 1849, at the age of nine, the father and son went to California on the English bark "Janet," arriving in San Francisco May 8, 1849. He grad. with an A.M. from Pacific Univ. (Santa Clara) in the class of 1861. In October 1862, he enlisted in the "California Hundred" which became a part of the 2nd Mass. Cavalry. He was mustered out in 1865 as a 1st Lieutenant. He became a carpet bagger in Mississippi and was appointed in 1867, by the Government of Reconstruction. Mayor of Yazoo City. He returned to the army in 1868, receiving a commission as 2nd Lieutenant in the 2nd U.S. Cavalry, July 5, 1868, and was for many years engaged in fighting Indians and scouting on the plains. From Aug. 22 to Sept. 24, 1870, he was in charge of the escort for the famous Washburn Expedition through the region of Yellowstone. His report on the first exploration of this region, published as a Senate executive document, has come to be regarded as a classic description and has never been surpassed. A peak, overlooking Yellowstone Lake in the Absaroka (Crow) Range, is named for him. He returned to the Yellowstone the next year, commanding the escort of the U.S. Geological survey and later, the Northwestern Pacific Railroad survey. He was promoted to 1st Lieut. in this year. He sought permission to explore the Nile, as he had earlier asked to make the first exploration of the Colorado River, but his requests were refused. He took part in the Sioux campaign. In attempting to reach the Columbia River from the Snake

River, he lost his boat. He reached the settlement three days later, traveling without food, after having lived twenty days on horse flesh.

In 1880, he went on an ill-fated Arctic expedition, commanding a vessel which became damaged and inserviceable. He was promoted to captain in 1884 and the next year, his command took the field against Geronimo's hostile Apaches. In his obituary, read at the Society of California Pioneers, it was said of him: "He was an ideal frontiersman and soldier of the trail; he was refined, courteous, gentlemanly in society. Possessed of a varied store of knowledge acquired by study, he had also gained, by personal observation and experience, that subtle information possessed by Indians, which is so hard to learn or to communicate to others. It is hard to realize that this powerful, bronzed, soldier of the mountains and the plains who had faced danger so often, who had encountered so many storms apparently unharmed, who had survived so many privations and hardships in his adventurous and active life and who seemed to be superior to every trial had died (at age 51) while yet in the strength of his manhood." See his "Personal Recollections—Two Yellowstone Expeditions" (in Theo. F. Rodenbough's "From Everglade to Canon with the second Dragoons") 1875, p. 405-419; his report upon the so-called Yellowstone Expedition, Wash., 1873.

iv. George E. 8 b. 1851, Santa Clara Co., Calif.; m. 1904, Irene W. Hayes, a native of Texas. He was educated in Santa Clara Co. and in San Francisco. He settled in San Diego Co. in what is known as Doane's Valley where he was in the hog and cattle business. In 1907, he became a ranch man in the Imperial Valley, later returning to Doane's Valley. He was a skilled hunter of mountain lions, bears, coyotes and side-winders. He also wrote both prose and poetry which found its way into various western publications. His colorful career, during the time he lived in Doane Valley on Palomar Mountain in San Diego County, are amusingly described in Catherine M. Wood's "Palomar, from Tepee to Telescope" (ca. 1937). Of this marriage, there was one son, Edwin, b. 1907.

The two men backed up and then ran out the exit door.

Muschong followed the two robbers at a distance and observed them run along a lane near the store's gas pumps. The robbers could see him follow and waved the gun at him several times in an attempt to scare him away. As the pair ran across a parking lot, Muschong saw one pull off his mask to reveal long blond hair. He then returned to the store and called 911.

Jeff Holt, Milan Deputy, said the call came in at 10:47 p.m. while he was driving his personal car through town. He looked up and saw a blue Buick 4-door that had been dispatched by other police departments as having been involved in another robbery.

Jeff Holt followed the Buick and was soon joined by Milan Marshal Dennis Ryker, then Tom Holt and Sunman Marshal Ray Doane. When officers turned on their red lights to stop the car a chase began westbound on S.R. 350 that escalated to 100 m.p.h.

Tom Holt said that Osgood Police Officer Steve Noble set up a road block near C.R. 100E. The fleeing car slowed as it passed through Noble's roadblock, giving Holt the opportunity to get ahead of the Buick. With one police car in front, one on the side (Ray's) and one in the back, the rolling road block ground to a halt.

Officers saturated the Buick with flood lights and ordered that all occupants put their hands on the car's ceiling and began to remove the robbery suspects. Holt said the car's three occupants were taken into custody without incident.

In the Ripley County Jail charged with armed robbery, a class B felony, is 19-year-old Daniel Richey and 20-year-old Daniel Shaver, both of Greensburg. Also taken into custody and then released to parents was a 17-year-old juvenile female, also of Greensburg.

Police served a search warrant on the suspects' vehicle Monday, April 25, but were unable to find the handgun. Officer Holt felt that the 9 mm handgun may have been thrown from the vehicle.

Police recovered a mask and some money in the car and a shoe left in a parking lot near the store, that will be used as evidence in the case. One of the suspects was missing a shoe when taken into custody.

Officer Holt states that he believes this group may be responsible for several additional armed robberies and stolen cars in a five-county area in southern Indiana. Two similar robberies took place in Bartholomew County, one in Greensburg on April 18, and one in Batesville on April 21. In the Batesville and Greensburg robberies, the employee on duty was handcuffed in a back room before the robbers made their getaway. In the Milan robbery, Muschong was not handcuffed.

Assisting in the investigation were officers from the State Police, Ripley County Sheriff's Department, Batesville, Sunman, Osgood, Versailles and Greensburg Police Departments and the Bartholomew County Sheriff's Department.

Attention: Dues Changes
